

# June 5, 2018 Primary Election NOTICE OF ELECTION

TO THE QUALIFIED ELECTORS OF WRIGHT COUNTY, IOWA:

Notice is hereby given that a Primary Election will be held on Tuesday, June 5, 2018, from (7:00 a.m.) seven o'clock a.m. until (9:00 p.m.) nine o'clock p.m. Iowa law states that in order to vote in the Primary Election you must choose either the Democratic, Republican, or Libertarian ballot. You may declare or change your party affiliation at the polls by filling out the eligibility form provided by the Precinct Election Official. Iowa law allows eligible persons the right to register to vote and cast a ballot on Election Day if they are able to provide proof of both their identity and residency at the polls. Absentee ballots are available in the Auditor's office if you are unable to make it to the polls on Election Day.

Voters are required to provide an approved form of identification at the polling place before they may receive and cast a ballot. Pre-registered voters who are unable to show approved ID may sign an oath of identification for an election held in 2018. Voters who are not pre-registered or who have changed precincts also may be required to provide proof of residence. Any voter who cannot show ID may have their identity attested to by another registered voter in the precinct who has proper ID. Starting January 1, 2019, all voters will be required to present an approved form of identification.
